The Warrior Alliance (TWA), a Georgia-based 501(c)(3) nonprofit organization, is hosting the 2<sup>nd</sup> annual Veteran Legal Services Clinic on Thursday, November 10, 2022 at Punch Bowl Social at The Battery Atlanta in celebration of Veterans Day. The event will attract hundreds of veterans, military families, and National Guard/Reservists seeking pro bono attorney consultation and help remove barriers to legal services access for Georgia's military and veteran community.

TWA's mission is to help Warriors and their families achieve a fulfilling civilian life by promoting collaboration between the organizations that can support them. The partnership with the Atlanta Braves, through the Atlanta Braves Foundation, supports TWA's goal for improving Warrior quality of life by establishing a new veteran facility, called "The Warrior Alliance Home Base" at The Battery Atlanta.

The coalition of legal service providers participating in the clinic include Atlanta Legal Aid, State Bar of Georgia, Georgia Legal Services Program, Emory Law Volunteer Clinic for Veterans, and University of Georgia School of Law. We are seeking volunteer attorneys to provide 30-45 minute consultations and volunteer paralegals to support various activities to include Warrior screening, processing of intake forms, and obtaining legal documentation as needed.

**Pro Bono Attorneys-** provide legal consultations and advice to Warriors that are pre-screened and assessed for case documentation and military status. Attorney requirements include:

- Legal expertise in one or more of the following areas: Military Benefits, Discharge Upgrade, Landlord-Tenant, Mortgage, Wills/Estate Planning, Debt Collection/Bankruptcy, and Civil/Family Law;
- Commitment of 3 hours from 9:00 AM -1:00 PM;
- Consultations to be scheduled in 30-45 minute increments.

**Paralegals-** provide Warrior screening, review of intake forms, legal case assessment, and pro bono requirement qualification, in addition to collecting case documentation. Paralegal requirements include:

- Volunteers to perform Warrior screening from October 24 through November 1, 2022;
- Volunteers to perform pre-clinic Warrior intake, assessment, and documentation beginning October 24 through November 4, 2022;
- Onsite volunteers day of the event for "walk-in" intake, assessment, and scheduling.
